CANVASS – MARCH 3, 2020 DEMOCRATIC PRIMARY

MEMBERS PRESENT: Chairman John Nunnally, Calvin Taylor, and Cheryl Johnson.

The Chairman called the meeting to order at 10:00 a.m. and determined that a quorum was present.

The Chairman stated that the Board would start the Canvass of Votes for the Democratic Primary.

Provisional Ballots: The Registrar was given the provisional ballots for research.

The Board reviewed each of the precinct’s paperwork for accuracy. The numbers reported on Election Night were correct.

On Motion by Johnson, seconded by Taylor, the Board moved that the Electoral Board of Caroline County convene in closed session pursuant to section [§24.2-653\(B\)](#) of the Code of Virginia for the purpose of considering whether each person who submitted a provisional vote at the election was qualified to do so, and I also move that the general registrar and any authorized representatives of candidates or political parties, as specified in section [§24.2-653\(B\)](#), be allowed to remain in the room during the closed meeting, and that any persons who cast provisional votes and who are present be allowed to enter the room while their qualifications are considered and to present any relevant information on their behalf to the board. Voting Aye: Nunnally, Taylor, and Johnson

On Motion by Johnson, seconded by Taylor, the Board moved that the Electoral Board of Caroline County certify that in the closed session just concluded the only matters discussed were the qualifications of provisional voters, as directed by [§24.2-653](#) of the Code of Virginia, and as identified in the motion to close the meeting pursuant to the Virginia Freedom of Information Act.

On Motion by Johnson, seconded by Taylor, the Board voted that the 3 Provisional Ballots did not meet the qualifications to be eligible to vote. Voting Aye: Nunnally, Taylor, and Johnson

Abstract of Votes – The Registrar provided the Abstracts for the Board to sign.
